MVAT analyzes funding proposals, scrutinizing for organizational financial health, program efficiencies, outcomes, and good governance practices. The Heroes Linked program, www.heroeslinked.org, was created to provide a unique opportunity for veterans, servicemen and women, and their families in the transition from active duty to civilian life. This online resource gives veterans, transitioning service members, and their spouses access to personal, phone-based professional development mentoring with private sector professionals. Through the use of proprietary software, a matching algorithm identifies areas of interest, experience, and goals between veterans and mentor advisors.
